Declaration on the compliance with POP Regulation

We, <u>Everspin Technologies Inc.</u> hereby certify the information related to substances identified in Persistent Organic Pollutants (EU POPs) & POPs treaty (Stockholm Convention on Persistent Organic Pollutants, including all amendments in force as of the signature date shown below. This communication applies to all the products sold or otherwise placed on the market by Everspin Technologies.

POPs, (Persistent organic pollutants) such as pesticides and some industry chemicals, which can be transported across international boundaries far from their sources and persist in the environment, bio accumulate through the food web and pose a risk to human health and the environment. The continuous release of POPs into the environment have been of serious concern to European Union since Regulation (EC) No 850/2004 of the European Parliament and of the Council on POPs entered into force in 2004. After being amended several times, the POPs regulation was cast into Regulation (EU) 2019/1021 of the European Parliament and of the Council in 2019.

We declare the compliance with the Regulation (EU) 2019/1021, as amended from time to time (POP), for all our products and packaging materials that are articles according to Art. 2(2). Based on the information provided by our supply-chain and to our best knowledge, all our products **is/are in compliant** with the POPs Regulation and don't contain substances subject to prohibitions listed in Annex 1 to Regulation (EU) 2019/1021.

- O Compliance with prohibition of the manufacturing, placing on the market and use of substances listed in Annex I, including all amendments in force specifically, UV-328 (added by Commission Delegated Regulation (EU) 2025/843) and Dechlorane Plus (added by Commission Delegated Regulation (EU) 2025/1930) whether on their own, in mixtures or in articles (Art. 3(1) and Annex I POP) for all our articles we have sold / shipped to the customer.
- O Compliance with restriction of the manufacturing, placing on the market and use of substances listed in Annex II, whether on their own, in mixtures or in articles (Art. 3(2) and Annex II POP) for all our articles we have sold / shipped to the customer.

Please note that the information being provided regarding the presence/absence of substances in the product(s) is/are based on information provided by suppliers/ producers of the raw materials in our supply chain.
